

# ARGENTINA QUALIFYING ROUNDS RULES SUPPLEMENT THE 2017 PHILIP C. JESSUP INTERNATIONAL LAW MOOT COURT COMPETITION

#### Argentina National Rule 0.0 – Argentina National Rules Supplement

The Argentina National Rules Supplement (the "Supplement") for the Philip C. Jessup International Law Moot Court Competition (the "Competition") has been adopted by the Jessup National Administrator for Argentina ("National Administrator") with the approval of the Executive Director (the "Executive Director") of the International Law Students Association ("ILSA"). The Supplement is intended to facilitate the conduct of the Argentina Qualifying Rounds. It clarifies and, wherever necessary, completes the Official Rules of the Competition.

#### Argentina National Rule 1.0 - Administration of the Argentina Qualifying Rounds

## Argentina National Rule 2.0 - Interpretation of the Supplement

Any questions as to the interpretation of the Supplement shall be addressed to the National Administrator. The Executive Director shall serve as final arbiter in implementation and interpretation of the Supplement.

### Argentina National Rule 3.0 – Schedule of Argentina Qualifying Rounds

The Argentina Qualifying Rounds of The 2017 Philip C. Jessup International Law Moot Court Competition will take place on March 3<sup>rd</sup> and 4<sup>th</sup>, 2017 at the headquarters of the Law School of the Torcuato Di Tella University located on Avenida Figueroa Alcorta 7350, Ciudad Autónoma de Buenos Aires, in accordance with the schedule attached to the Argentina Qualifying Rounds Rules Supplement.

# Argentina National Rule 4.0 - Organization of Qualifying Rounds

The national rounds will consist of two (2) preliminary rounds and one (1) championship round. In accordance with Official Rule 8(1), during the preliminary rounds each participating team shall plead as Applicant in one Round and Respondent in the other Round. The pairings of the preliminary rounds shall be determined by draw at the occasion of the exchange of memorials.

In accordance with Official Rule 8(5), the two top teams from the preliminary rounds will participate in the Championship Rounds.

The winner of the Championship Round shall be determined by the Judges in accordance with Official Rule 10(10)(a) and shall be the National Champion.

#### Argentina National Rule 5.0 – Pleading Option

The higher-ranking Team from the Preliminary Rounds shall have the right to choose which side it will argue during the Championship Round. This right is called the "pleading option."







To determine which is the higher-ranking Team after the preliminary rounds, the following criteria will be used: 1) Number of Wins as defined by Official Rule 10(7); 2) In case of a tie in the number of rounds won, the team with the highest Total Competition Raw Score, as defined by Official Rule 10(4), will be the higher-ranking team and, 3) In case of a tie in the number of rounds won and the Total Competition Raw Score, the team with the highest Total Competition Rounds Points, as defined by Official Rule 10(5), will be the higher-ranking team.

At the conclusion of the preliminary rounds, the teams will receive a copy of the Overall Rankings of the Preliminary Rounds, with the Total Win-Loss records, Overall Raw Scores, and Overall Round Point.

The higher-ranking team will be announced and will have 15 minutes to exercise its pleading option, after which the corresponding memorials will be exchanged.
