

# 2025 PHILIP C. JESSUP INTERNATIONAL LAW MOOT COURT COMPETITION

## INDIA QUALIFYING ROUNDS

### RULES SUPPLEMENT

The following Rules Supplement (the “Rules Supplement”) is adopted and promulgated pursuant to Official Rules 1.3, 1.4, and 1.6 of the 2025 Philip C. Jessup International Law Moot Court Competition and will apply to the conduct of the 2025 India Qualifying Rounds. Any Jessup Official Rules not modified by this Rules Supplement should be considered still in force.

#### **RULE SUPPLEMENT 1: ORGANIZATION OF THE COMPETITION**

##### **1.1 Administration**

The Qualifying Rounds are presented by Amity Law School, Noida. The National Administrator is Dr. Bhavna Batra ([bbatra@amity.edu](mailto:bbatra@amity.edu)).

##### **1.2 Structure of the Competition**

The Qualifying Rounds will be conducted in physical format at Amity Law School, Noida from 12<sup>th</sup> to 15<sup>th</sup> February 2025.

The Qualifying Rounds will consist of two phases: the Preliminary Rounds and the Advanced Rounds (the Quarterfinal, The Semifinal Round and the Championship Round). During the Preliminary Rounds, each Team will compete in four (4) matches, twice as Applicant and twice as Respondent.

##### **1.7 and 1.8 Power to Promulgate Additional Measures and Interpretation of Rules Supplement**

The National Administrator may promulgate additional measures for the orderly conduct of the Qualifying Rounds. Any questions concerning the Rules Supplement should be directed to the National Administrator, who shall have the power to interpret this Rules Supplement.

## **RULE SUPPLEMENT 8: QUALIFYING AND FRIENDLY ROUNDS**

### **8.1 through 8.7      Structure**

Based upon the rankings after the four Preliminary Rounds, the top eight teams will advance to the Quarterfinals.

The Semifinal Round will consist of two matches. The winning Team in each of the four Quarterfinal matches shall advance to the Semifinal Round. The winners of each Semifinal Round match will advance to the Championship Round. In all cases, the Pleading Option will be given to the higher-ranked team.

## **RULE SUPPLEMENT 12: AWARDS**

### **12.1   Awards**

The Qualifying Rounds will announce the following awards:

- (1) Champion
- (2) Runner-up
- (3) Semifinalists (2)
- (4) Top oralists in the Preliminary Rounds (10)
- (5) Top memorials in the Preliminary Rounds (5)

### **Teams Advancing to International Rounds**

No later than January 16, 2025, the ILSA Executive Office will announce how many Teams will advance to the International Rounds from the Qualifying Round. If the Executive Office announces that eight or fewer Teams will advance to the International Rounds from a given Mega-Regional, the four Teams that advance to the Semifinal Round will advance to the International Rounds. Additional Teams advancing to the International Rounds will be determined from among the Teams advancing to the Quarterfinal Round, in order of their ranking after the Preliminary Rounds.
