The Indonesian National Rules Supplement to the Official Rules of the 2025 Philip C. Jessup International Law Moot Court Competition. ("Indonesian National Rules Supplement") has been promulgated by the Indonesian National Administrator ("Administrator") with the approval of the Executive Director of the International Law Students Association ("Executive Director").

The present Indonesian National Rules Supplement is intended to facilitate the conduct of the 2025 Indonesian National Round of Philip C. Jessup International Law Moot Court Competition ("2025 Indonesian National Round"). The Indonesian National Rules Supplement clarifies and complements the Official Rules for the 2025 Philip C. Jessup International Law Moot Court Competition ("Official Rules"). The Administrator may set out supplemental guidelines pertaining to technical issues of the 2025 Indonesian National Round ("Technical Guidelines").

The Indonesian National Rules Supplement shall not preclude the Administrator from adopting any additional measure prior to, during, and following the 2025 Indonesian National Round pursuant to Rule 1.8 of the Official Rules.

Rule 1.0: Organization of the Competition and Number of Representatives from Indonesia

- 1.1 The 2025 Indonesian National Round is hosted by the Indonesian Society of International Law ("**INASIL**") and co-hosted by Universitas Indonesia.
- 1.2 The 2025 Indonesian National Round is administered by an Administrator appointed by INASIL and approved by the International Law Student Association:

1.3 The number of Indonesian Representatives to the International Rounds has been determined according to Rule 1.2(b) of the Official Rules resulting to be 4 teams.

Rule 2.0: Eligibility, Selection, and Outside Participation

2.1 In accordance with Rule 2.8, Rule 2.9, Rule 2.10, Rule 2.12, and Rule 3.4 of the Official Rules, every Team that has received assistance in the forms of practice or discussion with an individual for the purpose of obtaining feedback, advice, or commentary toward the Team's written Memorials and pleadings is obliged to register the said individual as a Team Advisor.

- 2.2 The following individuals are not permitted to advise a Team or to serve as a judge in practice Moots:
 - a) any Team Member from other Teams;
 - b) any individual who intends to serve as a judge in the 2025 Indonesian National Round; and
 - c) any individual who intends to serve as a committee in the 2025 Indonesian National Round or INASIL.
- 2.3 With regards to Rule 2.17 of the Official Rules, posting pictures of the Jessup Team or the Team Members on social media or publicly available websites does not constitute a violation of anonymity under the Official Rules nor the Indonesian National Rules Supplement.

Rule 3.0: Memorials

- 3.1 In accordance with Rule 5.1(b) of the Official Rules, all Teams shall submit their Applicant and Respondent Memorials to the Executive Office via the team homepage no later than 14 January of 2025 at 16:00 (4:00 p.m.) Central Standard Time (CST) (GMT 6).
- 3.2 Teams are not required to submit their Applicant and Respondent Memorials to the Administrator of the Indonesian National Rounds.
- 3.3 Teams that advance to the Elimination Rounds shall provide 6 (six) hard copies of each of their Applicant and Respondent Memorials to the Competition Division of the Administrator one day before the commencement of the Elimination Rounds.
- 3.4 In the event that Teams do not provide hard copies of their memorials as required in Rule 3.3 of the Indonesian National Rules Supplement, they will not be able to complete the reregistration process for the Elimination Rounds.
- 3.5 During Elimination Rounds:
 - a) Teams will receive a maximum of 2 (two) hard copies and a soft copy of the opposing Team's Applicant or Respondent Memorial.
 - b) The bench of judges will receive a hard copy of the relevant Applicant and Respondent Memorials.
 - c) The bench of judges may ask for an additional hard copy of the relevant Applicant and/or Respondent Memorial if necessary to assess the Team's oral presentation.
 - d) Teams and judges shall keep the given hard copies of the Memorial clean and intact.

e) The hard copies of the Memorials will be used for the entirety of the Elimination Rounds and must be returned to the committee at the end of each Match of the Elimination Rounds.

Rule 4.0: Procedure of Preliminary Oral Rounds

- 4.1 The Preliminary Rounds of the 2025 Indonesian National Round shall be conducted via Online Moot using Zoom as the platform.
- 4.2 The Administrator shall determine the pairings through a random draw. The pairings will be distributed to Teams prior to the Preliminary Rounds. The Administrator may modify the pairings to account for absent Teams or other contingencies.
- 4.3 After the Teams have been paired, Memorials of the opposing Teams shall be distributed to teams prior to the Preliminary Rounds. If Teams must be newly paired, they must be provided with their new opponent's Memorials as soon as reasonably possible, but at the very least 15 (fifteen) minutes prior to the start of the newly-paired Moot.
- 4.4 Prior to the commencement of the 2025 Indonesian National Round, the Administrator will hold a technical meeting for the Teams, judges, and observers. Teams are required to send at least one of the Team Members to attend the technical meeting.
- 4.5 Judges of the oral rounds will be selected in accordance with the spirit of Rule 4.1 of the Official Rules. In line with the independence and impartiality requirements, Judges of the oral rounds hold the duty to disclose any circumstances including but not limited to affiliation or relationship with a university (of which he or she is an alumnus), Coach, or Team Member, that might give rise to justifiable doubts as to his or her independence and impartiality.
- 4.6 The Administrator shall use his or her best endeavors to avoid placing a judge into an Oral Round in which an affiliation will arise by virtue of his or her relationship to the Competitor in that Round, such that his or her Independence will be impugned. In the event that the placement of the aforementioned judge in that round is unavoidable the Administrator shall ensure that: no more than 1 (one) affiliated judge is placed in an oral round and that said affiliated judge does not act as the President in that oral round.
- 4.7 In the event of technical difficulties, the procedure to be followed should be viewed as an extension of Rule 7.17 of the Official Rules, particularly subsections (f) and (h), which outlines the necessary steps for effective management and resolution of such issues to maintain the integrity of the proceedings.

Rule 5.0: Procedure of Elimination Rounds

- 5.1 The Elimination Rounds shall be conducted as In-Person Moot in accordance with Rule 6 of the Official Rules.
- 5.2 The Elimination Rounds of the 2025 Indonesian National Round will be held offline at Universitas Indonesia Jl. Lingkar, Pondok Cina, Kecamatan Beji, Kota Depok, Jawa Barat, 16424.
- 5.3 Teams shall arrive at the venue at least 60 (sixty) minutes before the commencement of the Elimination Rounds. Teams that advance to the next Match of the Elimination Rounds will be granted at least 45 (forty five) minutes of preparation time.
- 5.4 When a Team fails to appear for a scheduled Elimination Round, which will be conducted as In-Person Moot, the Administrator shall declare the Team as forfeiting from the competition after 10 (ten) minutes of waiting.
- 5.5 In accordance with Rules 4.6 and 4.7 of the Indonesian National Rules Supplement, the Administrator is dedicated to preserving the impartiality of judges by ensuring that their placements do not compromise their independence while also implementing procedures to effectively address any technical challenges that may arise, thereby safeguarding the integrity and fairness of the competition as stipulated in Rule 7.17 of the Official Rules.

Rule 6.0: Complaints About the Conduct or Result of a Match and the Conduct of the Indonesian National Rounds

- 6.1 In the event that teams intend to submit a claim regarding the conduct or result of a Match they shall do so according to Rule 11.10 of the Official Rules.
- 6.2 Complaints of the manner stipulated under Rule 6.1 of the Indonesian National Rules Supplement shall be reported to the Administrator as soon as the violation is known to the team, at the latest 15 minutes after the Match is completed. If the Team fails to report such violation within the specified time period, it is considered that the team has waived the rights to submit the claim.
- 6.3 In the event that teams intend to submit a claim regarding the conduct of the Indonesian National Rounds they shall do so according to the stipulations under Rule 11.11 of the Official Rules.
- 6.4 Burden of proof for all complaints falls upon the claiming party. The Administrator shall have the right to collect evidence through the conduct of interviews. All parties considered relevant to the claim are expected to be present and willing to participate.

6.5 All complaints and appeals made during the duration of the 2025 Indonesian National Round must be informed to the Administrator.

Rule 7.0: Technical Guidelines

- 7.1 The Administrator will complement the Indonesian National Rules Supplement with Technical Guidelines containing technical information and direction for the conduct of the 2025 Indonesian National Round.
- 7.2 In case of non-compliance of the Technical Guidelines, Teams, observers, spectators, and committees will not be admitted to the Zoom virtual room and/or be able to complete reregistration for the In-Person Moot.

Rule 8.0: *Ex Parte* or Reschedule Proceedings

- 8.1 When needed, the Administrator will use their best efforts to administer *ex parte* or reschedule Moots based on the available circumstances.
- 8.2 The Administrator will adopt the *ex parte* or reschedule procedure as provided under the Official Rules and may vary such procedures in the best interest of the 2025 Indonesian National Round.
- 8.3 In the case of Online Moot:
 - a) *Ex parte* and rescheduled Moots will be conducted only if a Team encounters technical difficulties that prevent the Team from participating in the Online Moot on the provided schedule;
 - b) Teams must notify the Administrator by providing evidence of the technical difficulty as soon as possible;
 - c) Following the consultation, the Administrator will use his or her right to determine whether to initiate *ex parte* or reschedule Moots.
- 8.4 In the case of In-Person Moot, the Administrator shall not conduct *ex parte* or reschedule Moots during the In-Person Moot, except under *force majeure* circumstances as follows:
 - a) Riot, rebellion, terrorism, pandemic, warfare, or blockade;
 - b) Natural disasters, including typhoons, floods, fires, or earthquakes; and/or
 - c) Government policy changes directly affect the commencement of the In-Person Moot.

Rule 9.0: 2025 Indonesian National Round Awards

- 9.1 The awards that will be presented to the participating Teams of the 2025 Indonesian National Round are as follows:
 - a) Champion Team;
 - b) Second Place Team;
 - c) Third Place Team;
 - d) Best Combined Memorials;
 - e) Second Best Combined Memorials;
 - f) Best Applicant Memorial;
 - g) Second Best Applicant Memorial;
 - h) Best Respondent Memorial;
 - i) Second Best Respondent Memorial;
 - j) Best Oralist;
 - k) Second Best Oralist;
 - l) Third Best Oralist; and
 - m) Spirit of Jessup Award.
- 9.2 The Administrator may create or reduce the awards as they see fit.

Rule 10.0: Copyright and Documentation

- 10.1 INASIL and the Administrator have the right to take any documentation in the form of screenshots, Match recordings, photographs, video footage, Match broadcasting on the internet, or any other kind of documentation for publicity purposes during the 2025 Indonesian National Round.
- 10.2 INASIL and the Administrator have the copyright of all documentation taken and made by the committee during the 2025 Indonesian National Round.
- 10.3 Accordingly to Rule 6.15 and 7.22 of the Official Rules, Teams, observers, and/or spectators are prohibited to take any documentation of any Match.

10.4 By registering and/or participating in the 2025 Indonesian National Round, all Participants of the 2025 Indonesian National Round are deemed to have consented to Rule 10 of the Indonesian National Rules Supplement.
